Certificate of Residency Form

(Instructions)

If you live in an Idaho County, other than Kootenai, you may wish to complete this form and submit it to that county so that some of your tuition and fees are paid.

Upon completing the form, mail or deliver the form to your county clerk for authorization. Forms will be posted to student's account as received and an email notification of receipt will be sent to your Cardinal mail, students are still responsible to pay the out-of-county tuition portion in full by the published due dates, unless we have received the approved form from your county. Check your MyNIC account for updated billing status.

Please do not contact the counties once you have submitted the form. If you have any questions regarding your Certificate of Residency, please contact Student Accounts at (208) 769-3344.

The Certificate of Residency form must be completed once every academic year. If you submit the form for Fall semester, it will be automatically applied to Spring semester. **NOTE: A Certificate of Residency does not need to be completed for Summer session.**

According to the Idaho Statute #33-2110A, the student shall pay the tuition and fees charged a student resident in the district, and the balance, if any, of the nonresident student tuition above the maximum liability of the county of his/her residence. No county shall be liable for out of district tuition unless the board of county commissioners of that county has first verified to the community college in writing the fact that the student is a resident of the county. Upon verification, the county shall thereafter be liable for the out of district tuition so long as the student is duly enrolled and attending the college.

(a) Liability shall be the term of the curriculum for which the student is enrolled, with a maximum lifetime liability of three thousand dollars (\$3,000)

The following counties require a new Certificate of Residency *EACH* semester:
Boise, Bonneville, Boundary, Butte, Canyon, Caribou, Cassia, Clark, Elmore, Fremont, Gooding, Jefferson, Lincoln, Minidoka, Oneida, Power and Washington.

Per the Idaho Statute #30-2110, all counties must be invoiced by the community college no later than, (Fall semester) October 15 and (Spring semester) March 15 each year. **NOTE: If your Certificate of Residency is not received in Student Accounts by these deadlines, they will not be processed per this Statute.

Certificate of Residency/Affidavit

Idaho Code §33-2110 requires that the county you resided in at least 12 consecutive months prior to attending classes pay part of your tuition (EXCEPT: Ada, Canyon, Kootenai, Jerome and Twin Falls Counties). It is your responsibility to prove legal residency by completing the form below. Some counties may require additional information or have you complete additional forms. If you have completed more than 6 semesters at NIC, you may not be eligible for the county tuition benefit. If the county cannot certify your legal residency, you are responsible for paying the county portion of your tuition by the scheduled payment dates.
